- 8. That the list of Governing body shall be furnished to the District Educational Officer every year.
- 9. That the pay structure or fee structure fixed by the governing body shall be got approved by the District Educational Officer every year.
- 10. That all the conditions prescribed in the G.O.s and other orders which are not specified in this order shall be complied with.
- 11. that the school shall not be closed without giving notice both to the parents, District Educational Officer and competent authority at least six months before.
- 12. That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
- 13. That the society shall submit proposals for renewal of recognition sufficiently in advanced (i.e) at least six months prior to the date of the present recognition.
- 14. All the appointments should be regulated as per norms stipulated in G.O.Ms.No.1 Edn. Dept. dated 01-01-1994.
- 15. Other conditions as per G.O.Ms.No.1 Edn. Dept. dated 01-01-1994, G.O.Ms.No.41 Edn. Dept. dated 11-05-2006 and G.O.Ms.No.74 Edn. Dept. dated 11-09-2006 should be followed from time to time.
- 16. Structural Soundness and Sanitary Certificates issued by the competent authority should be produced every year.
- 17. No Objection Certificate issued by the District Fire Officer should be submitted every year.
