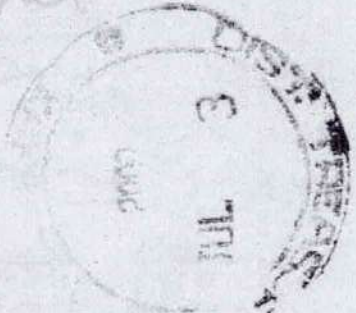

1. Name and Situation:

The name of the Trust is "SRI ANNAPURNA EDUCATIONAL TRUST" and the place of the Trust is at MANDAPETA. The Trustees may open offices or branches at such other places as may be deemed fit by them.

2. Objects:

- i. To establish, run and maintain educational institutions such as schools, colleges, training centres etc., for the purpose of giving education to the poor and other needy persons. And to dedicate sufficiently and properly for the said purposes from the funds of the trust.
- ii. To establish and run vocational training centres such as type writing, shorthand, computer education centres etc., for the welfare of poor and needy students.
- iii. To establish and run hostels for orphans, girls and disabled persons. And to run children homes for the poor and needy children.
- iv. To support and assist orphans, disabled, and poor children by providing scholarships etc.

The Trustees shall be collectively known as the Board of Trustees.

- b. The administration, management and control of the trust and its property shall vest in the hands of the Board of Trustees subject to other conditions mentioned infra.
- c. The trustees shall hold office during their life unless any of them desires to be discharged of his or her duties or becomes mentally or physically incapable of working or is declared insolvent or convicted of a criminal offence.
- d. The Board of Trustees have the right to co-opt any other person or persons as Trustees upon such terms and conditions as may be deemed fit by them.
- e. The Board of Trustees shall have the right to remove any one of the Trustees when any such Trustee is acting against the interests of the Trust or where the continuity of such Trustee in the Board of Trustees is causing ill will to the Trust.
- f. The Board of Trustees shall have the power to fill any vacancy that may arise on account of any of the Trustees ceasing to be a Trustee for any reason whatsoever.
- g. The Settler of the Trust shall be the Chairman of the Trust. The Board of Trustees may elect one among themselves as the Chairman for such period and upon such

terms and conditions as may be deemed fit by them from time to time.

h. The minimum number of trustees is two and the maximum number is nine.

4. Powers and duties of the Chairman of the Trust:

- The Chairman is empowered to construct or lease buildings for schools, colleges, training centres etc., for the activities of the trust with the assistance of other trustees.
- The Chairman will defray the expenses for duly running the trust and maintaining the same from out of the Trust Money or its income as may be necessary.
- The Chairman is empowered to accept gifts, either in cash or kind from any person or persons as long as the terms of such gifts are not inconsistent with the objects of the Trust.

- iv. The Chairman is entitled to invest the surplus amounts in his hand in such securities as he deems fit for the trust, subject to the provisions of the income-tax law prevalent at that time.
- v. The Chairman is entitled to open and operate bank accounts for the trust money. The Chairman is empowered to appoint and remove staff required for the trust and he is empowered to fix salaries and remunerations for such staff.
- vi. To carry on all kinds of transactions for the smooth and proper functioning of the trust.

5. Meetings:

- a. The Trustees may meet together as and when they may think necessary. But they should hold at least two meetings in a year. All the meetings shall be presided by the Chairman, or by his deputy in his absence.
- b. The Quorum at a meeting of the Trustees shall be two Trustees or one-third of the number of the Trustees, whichever is higher.
- c. The Chairman shall render the trust accounts and other financial statements to the Board of Trustees every year.
- d. The Trustees shall act, in regard to matters herein not provided for, according to the decisions of the majority of the Trustees. The Chairman shall have the casting vote in case of a tie.

6. Financial Year:

The Financial year of the trust shall commence on 1st April and close on 31st March of every year.

7. Bank Account:

The Chairman may open and operate any bank account or accounts in the name of the trust for and on behalf of the trust.

8. Advisory Board:

The Board of Trustees may constitute an Advisory Board to advise the Trustees on any matter concerning the achievement of the objects of the trust and the selection of the potential beneficiaries.

9. Accounts and Audit:

The Chairman shall cause proper accounts to be maintained. Such books may be audited annually by a Chartered Accountant appointed by the Board of Trustees.

10. Changes in the Constitution:

In the event of any change in the terms of the instrument of the Trust becoming necessary the same shall be undertaken only after obtaining the prior approval of the Commissioner of Income-Tax having jurisdiction over this Trust.

11. Dissolution:

In the event of extinguishment of the Trust on account of any reason whatsoever, the properties of the Trust - remaining after satisfying all the liabilities (if any) of the Trust - shall be given over to another public charitable trust which has similar objects and which has been registered under the Income-Tax Act as a Public Charitable Trust. The assets and properties of the trust shall in no case revert to the Settler of the Trust or his descendants or any other person.

Note: At present there is no immovable property for the Trust.
